

# RIPON CATHEDRAL

## TERMS AND CONDITIONS

### CHARGES

- a) As per the attached schedule of charges
- b) Account facilities will only be granted to those companies or individuals who have established credit facilities in advance.
- c) The Client agrees to pay all the Ripon Cathedral charges on the due dates, failing which interest will be charged monthly at 5%, as per our contract term.
- d) Ripon Cathedral reserves the right to withdraw credit facilities at any time without notice.
- e) Ripon Cathedral reserves the right to request a deposit or pre-payment at the time of confirming the booking.
- f) Breakages may be chargeable.
- g) VAT will be charged at the current rate.

### CANCELLATIONS

Ripon Cathedral reserves the right to charge the following sums for any loss of income due to cancellation, or non arrival, unless a booking is obtained for the same dates, from a third party, on non less favourable terms

Cancellation	-	1 and 3 months in advance	50% of total anticipated charges
Cancellation	-	14 and 31 days in advance	70% of total anticipated charges
Cancellation	-	3 and 14 days in advance	80% of total anticipated charges
Cancellation	-	less than 3 days in advance	100% of total anticipated charges

In all instances, notification of cancellation must be made in writing and will be effective on the date received by Ripon Cathedral

### LIABILITY

- a) Ripon Cathedral will be liable to the Client and/or person attending the function for injury to persons or loss or damage to property only where and to the extent that it has been negligent, but otherwise will be under no liability to them whatsoever.
- b) The Client will be liable for any loss or damage to Ripon Cathedral's property, including walls, light fittings and equipment (including items hired for their use) or injury to any person including Ripon Cathedral's staff and shall indemnify Ripon Cathedral against any loss or liability (other than Ripon Cathedral's liability in (a) above) arising from the function.
- c) The Client is advised to consider arranging insurance for the function covering public liability and loss or damage to its property and that of persons attending the function.
- d) Licensing Act 2003 – No licensable activities will take place unless the organiser ensures that a Personal License Holder/Cathedral Delegated Personal License Holder is present.

### GENERAL

Ripon Cathedral will take all reasonable steps to fulfil the reservation to the best of its ability and in accordance with details provided. However, it reserves the right to provide alternative venues/equipment with revised costs to the Client.

Whilst Ripon Cathedral will take all reasonable steps to fulfil the reservation to the best of its ability and in accordance with details provided. However, it reserves the right to provide alternative services of at least an equivalent standard at no extra cost to the Client.

Whilst Ripon Cathedral has taken all reasonable steps to ensure that the information contained in its brochures, tariffs, leaflets and advertisements is accurate, it reserves the right to alter, substitute or withdraw any facility or equipment without notice if necessary.

Notwithstanding anything contained in these Terms and Conditions Ripon Cathedral will not be liable for any failure to perform its obligations to the Client in whole or in part as a result of any of the following circumstances: strike, fire at or near Ripon Cathedral, flood at or near Ripon Cathedral, act of God, legal action against Ripon Cathedral, not resulting from its negligence, preventing the supply of services and War.
